

Habitat's Long Term Impact on Families

In a recent survey of our current habitat homeowners:

» 98% of homeowners report seeing positive changes in their life since partnering with Habitat;

» 88% of homeowners with school-aged children have reported an improvement in their children's grades;

» 59% of homeowners no longer receive government assistance.

Our Vision for our Community

In 2006, we celebrated our 20 year anniversary, building 20 homes, and reaching our vision to become a "Community Builder." (Term for a Habitat affiliate that builds 20+ homes per year) HFHNCC plans to continue at this rate for the next several years; greatly impacting the number of families living in poverty housing, while making a substantial difference in our local community.

Our Mission

Habitat for Humanity of New Castle County's unique approach to home construction helps low- to moderate income families break the cycle of poverty through the stability and empowerment of homeownership. Habitat gives these families a hand-up, restoring hope and dignity that poverty can strip away. Our mission is to build affordable housing, at no-profit through a combination of volunteer labor, 'sweat-equity' no-interest mortgages.

How Habitat Works

Habitat selects families based on their level of need, willingness to partner with us, and ability to re-pay the mortgage. Once the house is completed & the homeowner completes their program requirements, Habitat then sells the house, at-cost (~\$120,000) to our homeowners; a 20-30 year, 0% mortgage.



What Makes Habitat Different

Habitat offers 0% mortgage to selected homeowners who fulfill 225 hours of 'sweat equity,' complete a homeownership counseling program, and training program. Habitat recovers 100% of funds through homeowner mortgage payments to build future Habitat homes.

Who Habitat Serves

We serve local families in the lowest income brackets (30% – 60% of median income (earning approximately \$24,000 – \$46,700 for a family of four) that are living in substandard housing conditions; 80% are single mothers.

Local Statistics Demonstrate the Need

» Currently, over 7,300 families in New Castle County live in substandard conditions.

» 22% of rental households in Delaware live in conditions considered 'at-risk' (annual income less than \$20,000); this is one paycheck or one hardship away from losing shelter for their family.

» According to data collected by the Delaware Housing Coalition's 2005-2006 study "The Realities of Poverty," 10% of children in NCC ages 5-17 are living in poverty.

Current Facts

» One of the top three affiliates from Delaware to Maine (of over 200 affiliates) in terms of housing production.

» Completed 159 homes since 1986; 21 to be completed in 2010.

» Have over 120 active community partnerships, engaging 3,700(+) volunteers on our construction sites per year.

» Dedicates \$.93 of every dollar toward building homes.

» Focus on rebuilding neighborhoods including the 11th Street Bridge area, Prices Run, Minquadale and E. Lake Street in Middletown; communities in need of recovery and revitalization.
