### Webster Village I Dedication HFHNCC Dedicates 5 New Homes

Nervous smiles and warm hugs complemented a sunny and warm fall day in mid-October as five new homeowners accepted the keys to houses they helped build. On Friday, October 17, new neighbors Juanita Gonzales, Nyeesha Ringgold, Deanna Collazo, Andrea Thomas and Linda Evans stood alongside friends, family and local sponsors during the dedication ceremony for Habitat for Humanity of New Castle County's Webster Village I dedication ceremony.

The midday event featured a ribbon cutting signaling the completion of the first five of nine homes in the Webster Village development. The

last four remain under construction and will be completed in Janaury 2007. The five new houses bring Habitat's total number of homes built to 135 since 1986, and 51 in the 11th Street Bridge neighborhood, which is located in the northeast part of Wilmington.

Kevin L. Smith, Habitat's Executive Director, spoke of Habitat's emphasis on homeownership and community stability. "Our plans include helping hard-working families to achieve the American dream, and to help existing neighborhoods become better places to live. We take out blighted properties, build new homes and increase the homeownership rate in some of the poorest neighborhoods around New Castle County."

### Letter from the Executive Director

The elections are finally over and we have seen history made on several fronts. Kicking off the event with a musical selection, Seeds of Greatness Gospel Ministries lifted attendees' spirits. The dedication also highlighted the hard work of the homeowners, volunteers and project sponsors. Those sponsors in attendance included Federal Home Loan Bank (FHLB) of Pittsburgh, Wilmington Housing Partnership, JPMorgan Chase Foundation, Thrivent Builds (along with their community of local churches), and Westminster Presbyterian Church.

Councilwoman Stephanie Bolden, representing the City's 3rd district, was on hand to welcome the soon-to-be homeowners to the neighborhood. Sponsors like Federal Home Loan Bank's Dave Buches offered sage advice for new homeowner Juanita Gonzalez.

"First-time homeownership is a significant event in the life of any family," said Buches, FHLB's Community Investment Manager. "Studies show that homeownership creates more wealth for families, leads to greater family stability, improved performance by kids in school and pride in neighborhoods. We congratulate you

on your new home and wish you all the best."

Local clergy blessed the homes before attendees went inside for a tour. In other Webster Village news, the Home Dedication ceremony for the final four homes, known as Webster Village II, is tentatively scheduled for January 16, 2009 at 11 a.m. The remaining four homes were part of the Home Builder's Association of Delaware Blitz Build, allowing HFHNCC to complete the homes by the end of the year.

## Neighborhood Assistance Act

Looking for a way to help your community? Unsure of how to go about it?

Delaware State Housing Authority has implemented a program called the Neighborhood Assistance Act, which provdes an opportunity for businesses and individuals to receive a generous credit on their Delaware income tases in exchange for their support of qualified nonprofit organizations of their choice.

This program is a great way to support your neighborhood, support Habitat for Humanity of New Castle County, and get a tax credit at the same time.

Minimum investment amounts are \$10,000 for businesses and \$5,000 for individuals. Contributions can be in the form of goods or services, or they can be

direct financial contributions.

Participating tax payers are eligible for a tax credit of up to 50% of the value of their contribution. The maximum contribution is \$200,000.

## Miller's Row Now Under Roof

It seems like only yesterday that Habitat for Humanity of New Castle County celebrated the groundbreaking at Miller's Row, a seven house development at 22nd and Lamotte Streets in Wilmington. But as of early December, the development is under roof, installation is being put in, plumbing and HVAC, and electrical work taking place. On the exterior, brick masons have completed the Lamotte Street side.

### History

Miller's Row is also part of the Greater Brandywine Village district, one of several historic districts in the city. The development is scheduled to be completed by the end of March 2009. Before HFH, the site consisted of 10 boarded and vacant homes

Miller's Row was made possible by the generous contributions of many valued sponsors. Additionally, HFHNCC has partnered with Greater Brandywine Village Revitalization, Inc. (GBVR), whose goal is to improve the quality of life in the greater Brandywine Village area by developing and implementing a plan for the improvement of safety, housing conditions, transportation, economic development, and historical preservation.

They also work to coordinate the efforts of various civic and governmental orga-

nizations in revitalizing North Market Street and the Greater Brandywine Village area. Since Miller's Row is part of this plan, partnerthe ship includes HFHNCC, the City of Wilmington, and the GBVR project.

## Greenbridge II Breaks Ground

Keep an eye on your inboxes! Habitat for Humanity of New Castle County will be planning a groundbreaking ceremony for the final 10 homes on Thatcher St. in Wilmington, known as Greenbridge II, part of the 11th Street Bridge community. The foundations for the Greenbridge II homes were set in November and the site opened for volunteers on December 2.

By the time Greenbridge II is completed—likely the Fall of 2009-Habitat will have completed 61 homes in this community to date, including eight newly-completed town homes on N. Heald Street in Northeast Wilmington, known as Greenbridge I. The Greenbridge I homes are located directly behind the Greenbridge II development. Other Habitat homes in that community include the Webster Village development on 14th and 15th Streets at N. Heald in Wilmington.

For the Greenbridge project, Habitat partnered with the state of Delaware's Department of Natural Resources and Environmental Control (DNREC), implementing their Brownfields Program, which partners with organizations to clean up and develop unsafe, contaminated sites. For DN-

REC's part, the department revitalized the Greenbridge site by removing all the top two feet of contaminanted soil prior to construction. James Werner, director of DNREC's Division of Air & Waste Management, recently said, "Habitat for Humanity is perhaps our most valued partner in Brownfields development. They are firing on all cylinders in line with our policy for environmental cleanup investments: affordable housing, smart growth, and energy efficiency."

## Volunteer Update Housing Report: Rental Housing "Out of Reach"

A new report highlighting how "out of reach" rental units are for low income families further highlights the need for affordable housing that Habitat for Humanity of NCC can provide.

The report, "Out of Reach 2007-2008," was jointly released by the National Low Income Housing Coalition (NLIHC), a Washington, DC-based housing advocacy group, and the Delaware Housing Coalition.

"Out of Reach" provides the Housing Wage and related data for every state, metropolitan area and county in the country. Looking at Delaware, the report, points out that the Housing Wage for Delaware-the hourly wage a family must earn working 40 hours a week, 52 weeks a year-- is now \$16.61. Translated, this means the average low-income earner in Delaware will need to earn \$34,542 annually in order to afford rent and utilities. This is a 35% increase since 2000.

However, the typical renter in Delaware earns \$15.23, a \$1.38 below what is needed to afford a modest unit. An estimated 47% of renters in Delaware do not earn enough income to afford a two-bedroom unit at the Fair Market Rent.

And in tough economic times like this, our lowest income earners are struggling even more.

Statistics like this remind us how important a role Habitat NCC plays in helping our friends and neighbors in need of affordable housing. To our valued supporters, we thank you for donating your time and your financial assistance.
