## **Humanities and History**

#### **Early European Books**

Early European Books is an ambitious ongoing program serving researchers of the early modern period with exclusive content. Its aim: to digitize the extensive collection of all printed works in Europe between 1450-1700. New modules include:



#### Collection 7

This collection includes materials from Koninklijke Bibliotheek in The Hague, London's Wellcome Library and Copenhagen's Kongelige Bibliothek. Subject matter is an eclectic mix ranging from theology to science, mathematics to natural history, astronomy and philosophy, from state papers and histories to accounts of exploration and adventure. The contributions from the Wellcome Library add to an already extensive selection of early modern texts on medicine, science and alchemy, in addition to titles covering classical literature, philosophy and religion.

#### **Collection 8**

Released in September 2015, the first part of Collection 8 features about 70 percent of the collection's total planned content—more than 3,200 titles and over 1.12 million pages of content. A selection drawn entirely from works held at the Bibliothèque nationale de France in Paris, Collection 8 reflects early modern French intellectual, spiritual, political and everyday concerns, while at the same time reflecting a broader European outlook marking the Enlightenment period, a time of radical scientific advancement, overseas exploration and expansion of the known world.

#### Early English Books Online - TCP II

Early English Books Online is the definitive online collection of early printed works in English and works printed in England. Including more than 130,000 titles dating before 1700, these works are made more discoverable through an interface tailored specifically for early modern scholars. A second collection of more than 28,000 works of searchable transcriptions, available exclusively through ProQuest, has recently been added to the collection.

#### **History Vault**



These important archival collections document the most widely studied topics in 18th- through 20th-century

American history. A virtual anthology of primary sources, History Vault's sweeping coverage of U.S. History spans from the American Revolution to the last years of the 20th century. New modules include:

## Confidential U.S. State Department Central Files, 1960-1969

This module focuses on those U.S. State Department Central Files that have not been microfilmed by the National Archives or distributed by other publishers. It contains a wide range of sensitive materials from U.S. diplomats in foreign countries: reports on political, military, and socioeconomic matters; interviews and minutes of meetings with foreign government officials; important letters, instructions, and cables sent and received by U.S. diplomatic personnel; and reports and translations from foreign journals and newspapers. This collection is presented in three separate geographic modules:

- Highlights of the Europe and Latin America module include international reaction to the Bay of Pigs invasion, and East-West tensions in Berlin, Germany.
- Among issues in the Africa and Middle East module is the pivotal 1964 Rivonia trial of Nelson Mandela and leaders of the African National Congress.
- Topics in the Asia module cover the Cultural Revolution in China, and relations between Buddhists and the Vietnamese government.

## Coming soon! FBI Confidential Files and Radical Politics in the U.S., 1945-1972

This module contains records from the FBI and the Subversive Activities Control Board. Under the leadership of the infamous J. Edgar Hoover, the FBI vigorously investigated and tracked the activities of Communist groups, Communist-front groups, and other radical organizations in the United States. Highlights include Hoover's office files; documentation on the FBI's so-called "black bag jobs," as they were called before being renamed "surreptitious entries"; and the "Do Not File" File. Prominent subjects covered in the "Surreptitious Entries" file pertain to the Socialist Workers Party and the Weather Underground, both dating from the early 1970s. The records of the Subversive Activities Control Board (SACB), an invaluable resource for the study of left-wing radicalism of the 1950s and 1960s, are also included in this module.

## Southern Life and African American History, 1775-1915, Plantations Records, Parts 1 and 2

History Vault's Plantation Records document the far-reaching impact of plantation life on both the American South and the nation. Drawn from major repositories throughout the South, Plantation Records illuminates nearly every



aspect of plantation life. Because the plantation was a commercial enterprise, record keeping was essential. Many planters kept journals, crop books, overseers' journals, and account books in remarkable detail. Family members often kept personal diaries and corresponded extensively with friends and relatives near and far. Topics covered include business operations and day-to-day labor routines to family affairs, the roles of women, racial attitudes, relations between masters and slaves, social and cultural life, and shared values. Tensions and anxieties that were inseparable from a slave society are revealed with a fullness and candor unmatched by other available sources.

#### Coming soon! Women at Work during World War II: Rosie the Riveter and the Women's Army Corps

A highly unique resource, this module contains two major sets of records documenting the experience of American women during World War II: Records of the Women's Bureau of the U.S. Department of Labor, and Correspondence of the Director of the Women's Army Corps. Primary sources document a wide range of issues pertinent to women during this time of turbulent change, including studies on the treatment of women by unions in several midwestern industrial centers, and the influx of



women to industrial centers during the war. Topics covered in records and correspondence include women's work in war industries, pivotal issues like equal pay, childcare and race, and extensive documentation on the women who joined and served in the Women's Army Corps as WACs.

#### **Philosophy Database**

Researchers who require access to modern and historical full-text journal content are consulting contemporary dissertations to conduct their studies in ever greater numbers. Philosophy Database is a unique new full-text

journal and dissertations database specifically designed for researchers of all aspects of the interdisciplinary field of Philosophy. Philosophy Database contains the full-text of more than 160 philosophy scholarly journals as well as more than 1,000 modern and influential dissertations. Content covers the period 1860 to the present and is updated on a regular basis with new issues and new journal titles.

## **Historical Periodicals**

#### The Harper's Bazaar Archive

First published in 1867, Harper's Bazaar was American's first fashion magazine and presents a rich record of style, fashion and culture from the mid-19th century on, featuring the work of leading designers, photographers, artists, illustrators, writers and legendary editors-in-chief such as Carmel Snow and Diana Vreeland. In bringing this collection together digitally for the first time, ProQuest creates a comprehensive digital primary resource for the study of material culture, art, fashion, design, gender studies, marketing, brand history, and more.

#### **Women's Magazine Archive**

This rich resource comprises archival runs of leading women's consumer magazines of the 20th century. A unique collection of many of the most eminent and socially significant titles in this field, each of these monthly titles chronicles decades of social, historical and cultural trends. The titles are



considered essential primary sources by many researchers in the fields of gender studies, social history, business and marketing, fashion, media, and more.

#### **British Periodicals IV**



Offers a vast body of contemporary comment on the interests, attitudes, and events across three centuries of British history, culture, and politics. This

module will offer full-archival coverage of several leading magazines of the period including *The Field* (1853-2005), *Tribune* (1937-2005), *The Highway* (1903-1959), *War Weekly* (1939-1941).

A vast majority of recently declassified documents are published for the first time in this important compilation detailing nuclear weapons policies of the Nixon and Ford administrations, a period vital to understanding developments of subsequent years. In our post-Cold War world, nuclear proliferation, arms control, and atomic weapons deployment policies still remain at the core of public concern over global security and peaceful international relations.

#### **House of Lords Parliamentary Papers**

Partnership with the National Library of Scotland enabled the creation of this first digitized collection of the 19th-century House of Lords Parliamentary Papers. This archive covers wide areas of social, political, economic and foreign policy, sources indicative of the direction and interest of the Lords, previously considered lost to researchers and scholars, from a time when the House of Lords wielded considerable power.
